3. What is a cookie

Preference Cookies

Preference or functional cookies collect information about Your choices and preferences and make Your browsing more pleasant and personalised.

In particular, these cookies make it possible to memorise the language chosen during Your first visit to Our website or platform in order to personalise it accordingly.

Analytical (statistical) cookies

These cookies are used to gather information about Your use of the website or platform in order to improve the content of the Website, make it more suitable to Your needs and easier to use.

For example, these cookies show Us the most visited pages, or help to identify the difficulties that may be encountered during browsing.

For marketing purposes, Our website may from time to time also include pixel images such as Linkedin Insight Tag to track the website activity.
